Building Waste Container Skip Permit Application Conditions

- 1. The placement of waste containers or builders' skips on the roadside or nature strip is allowed once a permit is obtained. Bins will not be permitted in areas that would be considered dangerous or areas where parking restrictions apply or locations which adversely affect pedestrian movements.
- 2. Safety is Council's main concern, and bins can only be placed by companies which can provide safety and public liability insurance cover.
- 3. The applicant must pay fees in accordance with Council's Fees and Charges at the Council's Customer Service at the Council's Administration Building, 2 Bryant Street, Rockdale, NSW 2216.
